- 1. **PAYMENT TERMS:** Buyer understands and agrees to pay all charges within 30 days from the date on invoice. If payment is not made within 30 days, Buyer understands that a 1.5% finance charge per month (18% APR) will be added to Buyer's account at the end of each month after the initial 30 days. Buyer agrees to pay said charges. Account becomes COD if any invoice is over 60 days old.
- 2. **FREIGHT:** Unless otherwise specified by CAROLINA RETAIL PACKAGING, INC., Buyer agrees to pay all freight charges.
- 3. **RETURNS:** Return of "in-stock" merchandise for credit or exchange must be approved by CAROLINA RETAIL PACKAGING, INC., and must be in original packing and in saleable condition. Return of "in-stock" merchandise will be subject to a 15% "restocking fee". CUSTOM PRINTED MERCHANDISE CANNOT BE RETURNED, except in the case of manufacturer error. Returns of all merchandise must be within 3 months of purchase date to receive credit.
- 4. **CANCELLATIONS:** Cancellation of custom printed orders by Buyer will be subject to art/job prep charge and all other occurred expenses. Buyer agrees to pay all charges. Request for job cancellation should be faxed to (803) 359-7746, mailed, or e-mailed to sales@carolinaretail.com. Verbal requests will not be honored.
- 5. **ACTIONS, ATTORNEY'S FEES:** Should it be necessary to turn this account over for collection, Buyer agrees to pay all costs, including all finance charges, collection agency and/or attorney's fees.
- 6. **DEPOSITS:** A 75% deposit is required for initial custom printed orders & balance is subject to credit approval. A 100% deposit is required for initial stock orders.
- 7. **SMALL ORDER CHARGE:** Orders less than \$50.00 are subject to an \$10.00 small order charge.
- 8. **AUTHORIZATION TO OBTAIN CREDIT INFORMATION:** Buyer hereby authorizes Seller or any credit bureau employed by Seller to investigate the references listed herein.

**SECTION .3900 - CONTAINERS: WRAPPING: PACKING AND SHIPPING MATERIALS**

**.3901 - CONTAINERS: WRAPPING: PACKING AND SHIPPING MATERIALS**

(a) Sales to manufacturers, producers, wholesalers and retailers of wrapping paper, labels, bags, cartons and the other items specified in G.S. 105-164 .13(23) are not subject to the tax when such materials are used for packaging, shipping, or delivering tangible personal property sold at wholesale or retail, and when such materials constitute a part of the sale of such tangible personal property and are delivered with it to the customer. The exemption does not apply to items which are solely for delivery purposes and which do not become a part of the sale of tangible personal property.
